RE: Larimer County Colorado, 9-1-1 Surcharge Collection and Remittance

To whom it may concern;

Under C.R.S. § 29-11-102, you are required to impose a monthly 9-1-1 surcharge on your customers and monthly remit the 9-1-1 surcharge to the 9-1-1 Governing Body based on the county for the customer's billable address.

The 9-1-1 Surcharge for Larimer Emergency Telephone Authority (LETA) who's governing authority is Larimer County Colorado is **\$.70 per line per month.**

9-1-1 surcharge should be remitted to:

The counties that border Larimer County have a 9-1-1 surcharge significantly higher than our surcharge at \$.70. Some Cities or Towns cross county lines. However, the surcharge needs to be collected and remitted based on the county the address is located not based on the city or zip code.

It has been brought to our attention that some service providers are charging our citizens the incorrect 9-1-1 surcharge and remitting the 9-1-1 surcharge to the wrong governing body.


At this time LETA is not conducting an audit under C.R.S. § 29-11-103. Rather, LETA asks that you verify your remittance, correct any issues if found, and respond to this request verifying accuracy and / or verify corrections have been implemented.
